## **Education and Outreach**

- Explain to the public the importance of updating the comprehensive plan.
  - The comprehensive plan compiles public sentiment to reflect public values, concerns.
    - We could send a letter to the editor of the Enterprise to solicit interest.
  - Develop a survey
    - Explain why it is important to respond to the survey in an introduction.
    - Publish the responses.
    - Use Survey Monkey.
    - Ask respondents to identify approximate location of residence by marked areas on a map.
    - Questions should flow.
    - Possible questions:
      - Do you want to live in natural surroundings or do you prefer to see growth and development?
      - Would you be in favor of large scale solar PV in your neighborhood?
      - Why do you live in Knox? Or why did you move to Knox?
      - How long have you lived in Knox?
      - What do you like about Knox?
      - What changes would you like to see in your immediate neighborhood in coming years?
  - Need at least 50% response.
    - Make it simple publish instructions in the Enterprise, along with a deadline for responses.
    - Then if more responses are needed, have public meetings.
    - Then move to more creative outreach.
      - Collect email addresses from residents
  - Useful data:
    - How many people have moved to Knox since 2015? Get census data.
      - ACS American Community Survey federal annual updates have two(?) year old population statistics/estimates.
    - Measure churn using tax map information from the assessor?
    - Our population is aging.
- What safeguards do we have if our zoning ordinance is permissive, but threats exist?
- Minutes of all boards need to be posted on the town website.
  - CAC needs a website to post our minutes and to post information about our activities.
  - CAC would like to post information about topics such as geology, fossils, important resources...

# Map Library (for Open Space Inventory)

• Amy will coordinate with Peter about the map data he has gathered.

- Each map needs a narrative to explain its importance, perhaps including something like a SWOT analysis to indicate what characteristics to consider.
- Propose or emphasize the importance of following a review procedure for evaluating all projects.
- Indicate what maps to consult for some common types of development/projects.
- New national karst maps were published this week by USGS.
  - o Brigitte forwarded karst data maps from the USGS to us and to Betty Ketcham.
  - o Karst area seems to be all Farmington soils.
  - Albany County may have geology resource information?
- We'll want to look at aquifer studies, too.
- GIS software has instructions for application of layers.
- Ask ACDOH if they consider karst in approving septic plans, well constraints
- The CAC can offer advice on any project at any time.
- We can work with the Building and Zoning Administrator.

### Wetlands Boardwalk Restoration Project
