

LOCAL LAW NO. 1 of 1994

A LOCAL LAW amending Article I of Local Law No. 3 of 1992 of the Town of Knox, New York, to provide for the prohibition of dumping of sludge, septage, and sewage sludge, or other sludge or any products made from septage, sewage sludge or other sludge, upon lands in the Town of Knox.

BE IT ENACTED by the Town Board of the Town of Knox, New York as follows:

ARTICLE I of Local Law No. 3 of 1992 entitled Amendment to a Local Law to Establish and Define a Solid Waste Management Code is hereby amended by adding thereto certain terms as defined hereafter set forth, which is to read and provide as follows:

01-1 Definitions

New terms to be added.

"SLUDGE" means any solid, semisolid or liquid waste generated from a wastewater treatment plant, water supply treatment plant, or air pollution control facility.

"SEPTAGE" means the contents of a septic tank, cesspool, or other individual sewage treatment facility which receives domestic sewage wastes.

"SEWAGE SLUDGE" means the accumulated semisolids or solids resulting from treatment of wastewaters from publicly or privately owned or operated sewage treatment plants. Said term shall also include Class I compost.

New Definition of Solid Waste to Supersede and replace previous definition.

"SOLID WASTE" shall mean and include all putrescible and non-putrescible materials or substances, that are discarded or rejected as being spent, useless, worthless or in excess to the owners at the time of such discard or rejection, including but not limited to, garbage, refuse, industrial and commercial waste, sludges from water treatment facilities, rubbish, tires, ashes, fuel and gaseous material containers, incinerator residue, construction and demolition debris and offal. The term shall include solid or dissolved material in domestic sewage or substances, including, but not limited to, sludge, septage and sewage sludge and materials in non-containerized gaseous form. The final determination of whether or not a waste is "solid waste" shall be made by the Town Board and shall not be limited to those items or materials defined or excluded as solid waste by State and Federal law, rule or regulation.

01-2 Operation of Solid Waste Facilities

No land within the Town shall be used for the discharge, charge, disposal, deposit or burial of rubbish, garbage or solid wastes as defined in this chapter, unless the land is operated as a solid waste facility or transfer station by or on behalf of the Town or operated pursuant to a permit issued for said purposes by the Town and operated in accordance with all applicable laws, rules and regulations of the State of New York, County of Albany and Town.


No person shall receive or accept for disposal or deliver, dump or offer for disposal any garbage, refuse or recyclable

material on any land or at any location, site or area in the Town except 1) upon premises established, operated or maintained by the Town as a solid waste facility subject to all rules, regulations and restrictions governing the use of such premises as are herein described, and 2) upon premises authorized for sanitary landfill dumping under this law.


No person shall receive or accept for disposal or deliver, dump or offer for disposal any septage, sewage sludge or other sludge or any products made from septage, sewage sludge or other sludge on any land or at any location, site or area in the Town except 1) upon premises established, operated or maintained by the Town as a solid waste facility subject to all rules, regulations and restrictions governing the use of such premises as are herein described, and 2) upon premises authorized for sanitary landfill dumping under this law.


This act shall take effect immediately.


