Minutes of the 2018 Organizational Meeting of the Town Board January 1st, 2018

RESOLUTION 11-2018 - A motion was made by Councilman Barcomb and seconded by Councilman Barber to approve a contract for legal services and was carried unanimously.

Supervisor Lefkaditis disclosed prior engagements with WOH stating the following:

- (1) WOH served as special counsel to the Village of Altamont in a tax assessment matter which has concluded.
- (2) WOH has served as counsel to a private funding company of which the Town Supervisor Vasilios Lefkaditis is a member. This matter was serviced by the firm's corporate department and has concluded.
- (3) WOH serves as counsel to real estate company of which the Town Supervisor Vasilios Lefkaditis is a member. This matter is serviced by another attorney in the firm.
- (4) WOH served as counsel to Highway Superintendent Gary Salisbury on a real estate matter which has concluded.
- (5) WOH provided service to the Berne Knox Westerlo Board of Education while Supervisor Lefkaditis and Councilman Barcomb were members of the board.

Supervisor Lefkaditis pointed out that this contract is a \$3,500.00 savings from the prior contract held with the previous Town Attorney, with a broader base of services and 60+ members of the firm.

RESOLVED: to authorize Supervisor to enter into a Professional Services Contract with Javid Afzali of Whiteman Osterman & Hanna LLP and Whiteman Osterman & Hanna LLP at a rate of \$180.00 per hour not to exceed \$15,000.00 annually contingent upon the Town being provided with proof of appropriate malpractice insurance for Whiteman Osterman & Hanne LLP in an amount no less than \$1,000,000.00.
