Terri Ray, supervisor of the U.S. Section 8 Housing Choice Voucher Program for the Schenectady-based firm of Joseph E. Mastrianni, Inc., presented the 2006 statistics for the Housing Choice Voucher Plan for the Town of Knox that helps lower income families and the elderly with rental assistance. The Town currently has six families in the self sufficiency program, two participants, one escrow account.

Dan Driscoll reported that Steve Brown donated 138 acres on Bozenkill Road to the Mohawk Hudson Land Conservancy. The Conservancy requests the Town's assistance in grading the area, clearing some trees and applying a layer of shale. The Conservancy would like to add a kiosk at Winn Preserve to inform visitors about the trails, and again the Conservancy requests the Town's assistance in adding a parking area, and adding some shale. Dan also invites the Town Board on suggestions for naming the preserve. Supervisor Hammond and Highway Superintendent Salisbury to meet with Dan regarding parking area and discuss cost.

Mr. Hammond read a proposal to renew the Town's agreement with the City of Albany for the use of the City's Rapp Road Landfill facility for 2007, at the current tipping rate of \$52.00 per ton for Municipal Solid Waste.
