PROVIDED BY SECTION 458-a OF THE REAL PROPERTY TAX LAW

Be it enacted by the Town Board of the Town of Knox as follows:

SECTION 1: This local law shall be entitled "A Local Law of the Town of Knox reducing the Amount of Exemptions provided by Section 458-a of the Real Property Tax Law."

SECTION 2: Pursuant to the authority of paragraph(d) of subdivision 2 of Section 458-a of the Real Property Tax Law, the amount of exemption provided by the paragraphs (a), (b), and (c) of such subdivision 2 is hereby reduced as follows: (a) \$6,000; (b) \$4,000; (c) \$20,000.

SECTION 3: This local law shall take effect immediately upon filing in the office of the Secretary of State.

5. (City local law concerning Charter revision proposed by petition.)

I hereby certify that the local law annexed hereto, designated as local law No. of 19 of the City of having been submitted to referendum pursuant to the provisions of § 36 of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of such city voting thereon at the special election held on 19 became operative.

6. (County local law concerning adoption of Charter.)

I hereby certify that the local law annexed hereto, designated as Local Law No. of 19, of the County of, State of New York, having been submitted to the Electors at the General Election of November, 19, pursuant to subdivisions 5 and 7 of Section 33 of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of the cities of said county as a unit and of a majority of the qualified electors of the towns of said county considered as a unit voting at said general election, became operative.
