Section 1

Authority of the Town Board

Pursuant to the provisions of Section 1660 of the Vehicle and Traffic Law and Section ~~103~~¹³⁸(5) & (7) of the Town Law, the Town Board of the Town of Knox shall have the authority to prohibit, restrict, limit or otherwise regulate by order, rule or regulation, the stopping, standing or parking of motor vehicles on Town Hall Lane.

Section 2

Prohibited Parking Area

The parking, stopping, or standing of motor vehicles is prohibited on both sides of Town Hall Lane from the intersection of Route 156 and Town Hall Lane to and including the entrance to the parking lot of the Knox Firehouse due to the establishment of a fire lane.

Section 3

Penalty for Violation

Each person convicted of a violation of this Local Law shall be punished by a fine or imprisonment as prescribed by Section 1800 of the Vehicle and Traffic Law of the State of New York. In addition to the penalties provided herein when ever a motor vehicle is parked or standing or otherwise left unattended in this prohibited area such motor vehicle may be removed and stored by the Town of Knox, or any officer, agent or employee thereof. The owner of such motor vehicle shall be liable to the Town of Knox for the cost of such removal and storage, payment of which shall be required prior to the release of such motor vehicle.

Section 4

Effective date

This Local Law shall take effect immediately.




