On motion of Councilman Viscio, seconded by Councilman Decker, the following resolution was ADOPTED AYES 5 NAYS 0

RESOLVED that the Knox Town Supervisor is hereby authorized to execute a contract for the purchase of a 2009, Model 5600i, 4 x 4 SBA, plow/dump truck for the purchase price of \$ 182,275.44, said funds being expended from the highway capital reserve fund, utilizing the State Contract Purchase method, as authorized by law.

Within 10 days after the adoption of this resolution by the Town Board, the Town Clerk shall, as set forth in Town Law § 90, post and publish a notice which shall set for the date of the adoption of this resolution and contain an abstract of this resolution, concisely stating the purpose and effect thereof. Such notice shall specify that such resolution was adopted subject to a permissive referendum.

This resolution shall take effect immediately, unless a referendum is requested, in which event it shall take effect, if approved at such referendum, upon such approval.

This resolution is adopted subject to a permissive referendum pursuant to Town Law § 64(2).

#### RESOLUTION # 33 - ADOPT RECORDS RETENTION AND DISPOSITION SCHEDULE

RESOLVED, by the Town Board of the Town of Knox that Records Retention and Disposition Schedule MU-1, issued pursuant to Article 57-A of the Arts & Cultural Affairs Law, and containing legal minimum retention periods for local government records, is hereby adopted for use by all officers in legally disposing of valueless records listed therein.

#### FURTHER RESOLVED, that in accordance with Article 57-A:

- (a) only those records will be disposed of that are described in Records Retention and Disposition Schedule MU-1 after they have met the minimum retention periods described therein;
- (b) only those records will be disposed of that do not have sufficient administrative, fiscal, legal, or historical value to merit retention beyond established legal minimum periods.

Supervisor Hammond read letter from Frank Fuss, who is a volunteer fireman, requesting information on health insurance though municipalities. He would like to know specifics on cost and health insurance coverage. Supervisor Hammond gave letter to Town Attorney Dorfman to review.

Highway Superintendent Salisbury announced new highway employee, Donald Wagoner, Sr.

Supervisor Hammond reported sales tax revenue and mortgage tax is down compared to previous years. Town received Time Warner Cable check for \$14,636.04.

Supervisor Hammond reported the check writer he uses for writing checks needs repairs, found a company to replace for \$315.00.

Winter Fest was last Saturday, with an excellent attendance. A special thank you to the Antique Car Club for the demonstration of the Model T snowmobiles, the Highway Employees for plowing the parking lot and Ed Schmitt for hanging the canvass to break the wind.

Highway Superintendent Salisbury reported he has not done the 284 agreement, no major projects this year, a lot of tree work. Attending a FEMA meeting with Supervisor Hammond. Highway Superintendent Salisbury would like to upgrade two way radios in the trucks, currently the radios are on low frequency, which have interference, cannot communicate across town, let alone on the same road. Salisbury to negociate annual contract price. Town Board agrees to purchase additional base for the Town Hall.
