RESOLVED to authorize Robert Price to attend Windustry's Community Wind Energy 2008 seminar, for the amount of \$125.00

Cheryl Frantzen presented a letter on behalf of the Conservation Advisory Council, proposing the Town Board adopt the U.S. Green Building Council: Leadership in Energy and Environmental Design (LEED) Green Building Rating System in the planning of the Knox Town Hall renovations. Supervisor Hammond to speak with Susan Lombardi.

Town Board members have reviewed contracts from three companies, Enterprise Consulting Solutions (ECS) of Slingerlands, JNS Enterprises of Central Valley, and Infinigy in Albany. ECS is owned by Scott Carroll and represented by Jacqueline Phillips Murray. ECS is currently working on a cell tower in New Scotland. Bill Biscone, who represents ECS, said construction on the New Scotland tower will begin in late May or early June. Councilman Viscio said, "correct me if I'm wrong," "the New Scotland tower is the only tower project that you have waiting ready to build right now?" Bill Biscone said it is. "Worst case scenario," Viscio said, "the company doesn't pan out. We've got a tower built over here. Where do we go? What happens?" "I'm not questioning the viability of your company, but I'm just looking at the fact that, if we have a situation where we don't have a site manager at some point, given an unforeseen economic situation, where does that leave the town?" "We own it," said Dorfman. To project revenue, Price created two spreadsheets that span 10 years. He considered to scenarios that had been presented to him by ECS's president. The town and ECS would either split the rent charged to cellular carriers 50/50 or 53/47, with Knox receiving 53 percent.
