RESOLUTION #43 – OPEN PUBLIC HEARING ON ESTABLISHING A MAXIMUM WEIGHT LIMIT ON DUTCH SETTLEMENT ROAD

On motion of Councilman Decker, seconded by Councilman Barber, the following resolution was ADOPTED AYES 5 NAYS 0

RESOLVED to open public hearing on the weight limit of Dutch Settlement Road.

Robert Price asked why the town is establishing a lower weight limit. Highway Superintendent Salisbury reported that the bank along the Fox Creek has become unstable since Hurricane Irene. Larger trucks have been traveling that road and damaged the guardrails. Highway Superintendent Salisbury has the appropriate permits to begin work from New York State Department of Environmental Conservation.

With no other comments regarding the weight limit, the public hearing will remain open for public comment.

Robert Altieri presented the board with a copy of a resolution to oppose the NY SAFE ACT. The copy was from the Town of Westerlo, in which a resolution was passed to oppose the NY SAFE ACT.

Brian Fish reported that sections of the NY SAFE ACT have been postponed. Parts A and C have been postponed.

Kim Swain addressed the board regarding her concerns with the SAFE ACT and would like the board to consider a resolution opposing it.

Town Attorney Dorfman asked how other towns are handling this.

County Legislature Deborah Busch reported Westerlo passed a resolution followed by the proclamation. Berne is holding a public hearing on this tomorrow and Rensselaerville passed a resolution in opposition as well, for a full repeal of the SAFE ACT. Fifty Seven out of the sixty two counties in New York State have passed resolutions for the repeal of the SAFE ACT.

Brian Fish added three arguments of this: a second amendment right, the time frame in which this law was passed, and funding.

Deborah Busch suggests holding a public hearing for input on the resident's views and interests on this topic. Towns, as well as cities are in opposition of this.

Robert Altieri grew up in East Berne and moved to Knox, four years ago. He grew up hunting and fishing. With Governor Cuomo passing this overnight, it's not right.

Supervisor Hammond stated his feelings are mutual, the aging process was to short for the passing of this law. He supports all who sit here tonight and came prepared. Knowing what was taking place in other surrounding towns; he prepared a resolution and would like to offer what he wrote.

Robert Altieri asked how the town board could pass a resolution without a public hearing.

Robert Price asked for a reason why the town can not hold a public hearing on this issue.

Town Attorney Dorfman stated he cannot tell the town board to go ahead with a public hearing. He has a responsibility to advise the board, he cannot tell the board to pass a resolution advising the state that the SAFE ACT is unconstitutional.

Tom Cavanaugh stated a full repeal is not unconstitutional.

Pamela Fenoff suggested using other language other than unconstitutional, this resolution that you passed does nothing for the people in this town. We don't want it reviewed, we want it repealed.

County Legislature Travis Stevens suggested holding a public forum and invite the state representatives here for discussion.

John Elberfeld stated that not everyone wants it repealed.

Tracy Salisbury applauds the board, but you are the elected officials, elected by us, and this resolution was passed just like the SAFE ACT was. She works in the health care field and part of the SAFE ACT is to disclose medical information regarding patients, not right it doing that. The guns in our family that have been handed down from generation to generation, now those are illegal. Everything starts at the bottom, and that is why we came to you this evening.

Pamela Fenoff asked how the board could pass a resolution, when you have one person in favor of the SAFE ACT and a room full against it. This resolution that the board just passed has zero effect, can't the board change the wording to support the residents.

Audience members asked the board to change the wording on the resolution and add other language to it. If the board knew that this discussion was going to take place, why didn't the board members find out what other towns are doing?

Robert Altieri stated that the board has heard the views of the residents here tonight; he would like to know their personal opinions.

Councilwoman Pokorny stated that municipal boards do not pass resolutions regarding abortion, car licenses or gay marriage. Personally she is in favor of gun control but as an elected official she has heard the views from the crowd this evening and feels the resolution passed this evening will be effective.

Councilman Viscio stated his opinion was not relevant and he voted on the resolution based on the town attorney's recommendations.

WHEREAS, the Town of Knox has received a written request from the Village of Altamont to grant tax exemption from Knox Town taxes to certain properties owned by the Village of Altamont in the Town of Knox outside the incorporated Village of Altamont;

WHEREAS, The Town of Knox has considered the request form the Village of Altamont;

NOW, THEREFORE, BE IT RESOLVED as follows:

That the Town of Knox does hereby adopt this resolution denying the request of the Village of Altamont to exempt certain properties In the Town of Knox outside of the Village of Altamont which said properties are used by the Village of Altamont for water supply purposes.

Town Attorney Dorfman reported that the Village of Altamont requested notification, and notification was given today in person.

Last month discussed lowering the speed limit on Old Stage Road, a resolution needed for a petition to the State Department of Transportation. Supervisor Hammond announced that Crow Hill should be added to the formal resolution.

Three basic questions listed on this survey, would like to hold public discussions during this process. Establish an end date for the return of the surveys. Thomas Wolfe would like to sit on the committee for review of the comprehensive plan.
