He went to New Scotland's Town Board meeting and are looking to adopt another Town's policy on wind turbines. Green thinks that the town's should adopt their own policies.

Robert Price was at the Pill Box Tower at 5:00 this evening and reported that the tower will be installed on the 25th of this month. National Grid was at the site today and cut down many unnecessary trees. Price thinks that a representative from the Town Board should have been at

the site to oversee this project.

Hammond and the Highway Department employees unloaded and placed all 14 boxes in the park equipment garage behind the Town Hall. Supervisor Hammond suggested a storage box until the Town Hall Renovation Project is complete.

The board agreed to store the court's furniture in the park equipment garage until October and then move the boxes into the basement of the Town Hall.
