Terri Ray, Supervisor of the U.S. Section 8 HUD Housing Choice Voucher Program for the Schenectady-based firm of Joseph Mastrianni, Inc., presented the 2008 statistics for the Housing Choice Voucher Plan, which helps lower income families and the elderly with rental assistance. The Town of Knox, which in past years has been able to help twenty families, is down to seventeen, due to the economic crisis, the funding is no longer available. There are currently ten on the waiting list, one who lives in the Town of Knox has priority over the other nine. Jim Mastrianni spoke with Supervisor Hammond and stated that a public hearing is no longer a requirement for communities with less than 600.

RESOLVED to suspend regular board meeting in order to hold public hearing for comments on the Preliminary Budget for 2009.

Charlie Sacco discussed the status on the Town Hall project. Sent correspondence to board members with changes made to Plan B floor plans on renovation. Changes such as turning of the elevator ninety degrees from original plan, which will make lobby more compact. Changing the downstairs bathroom ninety degrees. The revised plan will be released to the engineers tomorrow, November 6, 2008. The bidding process will start approximately early next year. Charlie will have a minor set back, he is having surgery next week.

Supervisor Hammond asked if the downstairs flooring will be finished? Will furnace be updated as well as adding cool air through out the whole building? Charlie Sacco answered yes to both questions.

Supervisor Hammond announced a seminar tomorrow, November 6, 2008 in Troy for grants for renovations for record storage.

Supervisor Hammond asked, "what about gutters?" Charlie Sacco said "he doesn't like gutters, he prefers a natural runoff."

Supervisor Hammond would also like to see the downstairs treated for the mildew problem. Take off old sheet rock and treat with mold and mildew remover and finish.

Discussion for adding a kitchen sink and counter space in the new building.

Councilwoman Gage expressed her concerns regarding vandalism in the downstairs bathrooms.

RESOLVED to authorize supervisor to make the annual employer contribution payment to the New York State Local Retirement System, for a total of \$30,450.00 for the year 2009.

Supervisor Hammond presented a local law for the review of the Town Board Members for the recycling operations at the Transfer Station. Supervisor Hammond will also make sure Town Attorney Dorfman has a copy to review. Would like to make a resolution at the December 9th board meeting to hold a public hearing for the adoption of this local law.

Supervisor Hammond announced that Lou Tubbs has been filling in the vacancy at the Transfer Station and has enjoyed working there. Supervisor Hammond would like to recommend to the board, that Lou Tubbs fill this position. Councilwoman Gage thought the Town Board would post the position in the local paper and review the resumes, and make a final decision from there. Highway Superintendent Salisbury reported that he has already received one resume. The Town Board will review the resumes at the December 9th board meeting.

Supervisor Hammond reported that two invoices need to be paid for the Town Hall Renovation Project. Supervisor Hammond announced that grant money received last year will be used to pay for these two invoices.

The first bid from Lowe's is for home grade carpet for \$898.25 including tax, which the town is tax exempt and the second bid is from Tom Kruger, which is commercial grade carpet for \$885.95, including the removal of old carpet and furniture removal.

Highway Superintendent Salisbury reported that he has received concerns from the Knox Fire Department regarding Town Hall Lane, the road between the Town Hall and the Fire Department. The road will need to be re-designed for the Town Hall renovations. The fire company has concerns with boundaries. Supervisor Hammond, Highway Superintendent Salisbury and Councilman Decker will meet with the Fire Department and discuss the changes.

Robert Price recommended that the fee schedule be amended as follows:
