On motion of Councilman Barber, seconded by Councilwoman Pokorny, the following resolution was ADOPTED AYES 5 NAYS 0

RESOLVED to authorize the Supervisor to enter into agreement with Mohawk Hudson Animal Shelter for services for fiscal year 2014.

Town Clerk Swain reported on the changes taking effect January 1, 2014 for the New York State Department of Environmental Conservation for the selling of hunting and fishing licenses. The contract between the state and the agency that provides the software will expire on December 31, 2013. Equipment that has been provided will no longer be used in the sales process; all sales will be sold through a website from NYSDEC. NYSDEC will be conducting training on the new software, in which Town Clerk Swain will be attending on November 13, 2013 in Cobleskill. A new License Issuing Agent Agreement needs to be filled out and returned by December 15, 2013.

Whereas, New York State Department of Environmental Conservation is authorized by Section 11-0713 of the Environmental Conservation Law to Appoint agents to issue licenses for the privilege of hunting and fishing in New York State; and

NOW, THEREFORE, BE IT RESOLVED that the Knox Town Supervisor is hereby authorized to execute a License Issuing Agent Agreement with the New York State Department of Environmental Conservation as set forth in the attached License Issuing Agent Agreement.

RESOLUTION #105 -AUTHORIZE SUPERVISOR TO ENTER INTO AGREEMENT WITH NYSDEC FOR ISSUING HUNTING AND FISHING LICENSES

RESOLVED to authorize Supervisor to enter into agreement with New York State Department of Environmental Conservation for the issuing of hunting and fishing licenses.

Supervisor Hammond reported that AT&T would like to add 4G service to the cell tower. More revenue for the town. Execute an amendment to the agreement.

Whereas, the Town of Knox, ("Town"), Enterprise Consulting Solutions, LLC, ("ECS") and NEW CINGULAR WIRELESS PCS, LLC, (Lessee) entered into a Site Lease Agreement dated September 28, 2009, whereby Town and ECS leased to Lessee certain Premises, therein described, that are a portion of the Property located at 163 Street Road in the Town of Knox, County of Albany, State of New York ("Agreement"); and

WHEREAS, Town, ECS and Lessee desire to amend the Agreement to allow for the installation of additional antennas, associated cables and other communications instruments resulting in additional rents pursuant to the terms of the original Agreement; and

WHEREAS, Town, ECS and Lessee, in their mutual interest, wish to amend the Agreement to allow for the installation of additional antennas, associated cables and other communications instruments resulting in additional rents pursuant to the terms of the original Agreement.

NOW, THEREFORE, BE IT RESOLVED, that The Knox Town Supervisor is hereby authorized to execute an Amendment to the site lease agreement dated September 28, 2009 with Enterprise Consulting Solutions, LLC, ("ECS") and NEW CINGULAR WIRELESS PCS, LLC, (Lessee) for a portion of premises located at 163 Street Road, Town of Knox, New York for the purposes of the installation, maintenance and operation of a telecommunications facility upon said premises, additional rents to be paid by Lessee and update addresses for Notices to the parties.

Highway Superintendent Salisbury reported that he has billed everything for Hill and Dale Road at the federal level and the town should be reimbursed quickly. Dutch Settlement Road project is all funded by the state and that will take longer to receive. The SAMS issue has been resolved.

Highway Superintendent Salisbury has had three individuals submit applications for the part time winter help position. Two of those are residents of Knox, and prefers to hire within the town. Will be conducting interviews the week of November 12th. He spoke with Louis Saddlemire, which he would be available during the day, but would like to have two people that he could have on standby as needed. He would also need an hourly rate.

Trucks are all set for the winter months; had to replace the motor on the sander.

The Knox Historical Society would like to place a barn quilt on a 4X4 post in the ground and attach three 2'X2' barn quilts in support of the Helderberg Quilt Barn Trail.

RESOLUTION #108 – AUTHORIZE THE HISTORICAL SOCIETY TO INSTALL A MONOPOLE TO HOLD BARN QUILTS

Councilwoman Pokorny reported that she's received 48 responses on the vision survey for the Comprehensive Plan, and 16 responses of the agriculture survey. She would like to hold a workshop on the 26th of November at 7:00 p.m. to review and edit the responses. To be published on the website and Hilltown Channel 17 News and the Altamont Enterprise.

Robert Price announced that March 29, 2014 would be the date of the American Red Cross Blood Drive at the Town Hall; More information to follow.

Robert Price reported by mid month, all members of the Planning Board should have attended training.

Robert Price reported that he is restoring an old water pump from the Historical Society Building, and while there he looked at the floor joists where the old voting machine will be placed. The beams need to be supported if the voting machine will be placed there. Contact John DeMis to look at and possibly supply drawings of the scope of work involved in supporting the beams.

Marie Viscio suggested keep all the "cool" parts of the machine and discard the base. Town Attorney Dorfman to find out if Albany County or the town owns the machine.
